## Playing MP3

This unit can play MP3 files you have recorded to discs.
MPEG Layer-3 audio decoding technology licensed from Fraunhofer IIS and Thomson multimedia.

## Large, two-line display

This unit can display the MP3 album title, track title and the MP3 ID3 artist name, ID3 track title entered on your computer.

## HOLD

This function causes the unit to ignore accidental button presses. Set to HOLD so the unit doesn't power on accidentally or play is interrupted.

## Note on CD-R and CD-RW

This unit can play CD-R and CD-RW recorded with CD-DA or MP3. Use an audio recording disc for CD-DA and finalize it when you finish recording. The unit may not be able to play some discs due to the condition of the recording.
※A process performed after recording that enables CD-R/CD-RW players to play audio CD-R and CD-RW.

## Resume function

Play begins from the last point stopped. Replacing the disc cancels the function.

## Auto off function

If the unit is left in stop mode for approximately 10 minutes, the unit turns itself off automatically.

## Troubleshooting guide

## - Specifying the AB segment

Press $[\bullet$ MEMO $/ \sim$ DISP] at the start point $(A)$ and once more at the end point $(B)$.
'A'С'B'

- Stop or skip ( $\lrcorner$ page 5 ) to cancel.
- If you do not specify point $B$ and reach the end of disc, point $B$ is set automatically and repeat begins. You can also specify point $B$ again by pressing [•MEMO/ © DISP].
- You cannot select "RND" and "A $\subset$ B" while playing MP3.


## Anti-Skip System

This system reduces skipping caused by vibration to a minimum. You can change the anti-skip memory time for CD-DA to improve sound quality. While stopped, each time you press and hold [•MEMO/ - DISP]


- You cannot change the memory time for MP3. It is a maximum of 100 seconds for MP3 recorded at 128 kbps .
